What is this type of insurance?

Radio Aid Systems insurance provides accidental damage, accidental loss, fire damage, flood damage, liquid damage, malicious damage, misappropriation and theft cover for Radio Aid Systems supplied to pupils who are attending the school.

This insurance is underwritten by AmTrust Europe Ltd which is registered in the UK under number 1229676. AmTrust Europe Ltd is authorised by the Prudential Regulation Authority and regulated by the Financial Conduct Authority and Prudential Regulation Authority. What is insured?



Your Radio Aid System is covered against the cost of repair, or at our choice, replacement due to:

- ✓ Accidental damage
- ✓ Accidental loss
- ✓ Fire damage
- ✓ Flood damage
- ✓ Liquid damage
- ✓ Malicious damage
- ✓ Misappropriation
- ✓ Theft

What is not insured?



- ✗ Mechanical breakdown
- ✗ Wear and tear or cosmetic damage
- ✗ Theft of your Radio Aid System from any motor vehicle between 22:00 and 06:00
- ✗ Accidental loss or theft of your Radio Aid System where the circumstances cannot be clearly identified. You must be able to confirm the place and time of the accidental loss or theft.
- ✗ Any malicious act committed by you
- ✗ Any accidental damage, liquid damage and malicious damage to Your Radio Aid System if the Radio Aid System cannot be provided to Us for repair or inspection

Are there any restrictions on cover?



No cover is in place for any Radio Aid System not stated on your Policy Schedule.

Where am I covered?



✓ Your Radio Aid System is covered whilst within the United Kingdom and for up to 30 days worldwide in any 12-month period, including whilst on a family holiday or course trip. However, please note that all claims administration, repairs and/or replacement will take place in the United Kingdom only.

What are my obligations?



- Please supply accurate and complete answers to all questions we may ask you.
- Please tell us of any changes to your details as soon as is reasonably possible.
- You must report any claim to us as soon as is reasonably possible.
- Please prevent any further damage to your Radio Aid System and retain all damaged components for inspection.
- A theft or misappropriation must be reported to the police within 72 hours of you discovering the theft or misappropriation.

When and how do I pay?



We will invoice you for the annual premium based on the number of pupils/users you have declared to us.

When does the cover start and end?



The policy start, and end date can be found on your Policy Schedule and lasts for a period of 12 months.

How do I cancel the contract?



You may cancel the policy at any time by giving 14 days' notice. If you cancel within the first 14 days of receipt of the policy documentation, providing there has been no claim or incident likely to give rise to a claim, we will refund any premium paid.

If you cancel this policy after 14 days of receipt of the policy documentation and there has been no claim (or claim pending) during the period of insurance, we will calculate the pro-rata premium for the period you have been insured and refund any balance.
